WHAT DOES Velloci, Inc. DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> ■ Social Security number of Beneficial owners and EIN and ■ Credit and Insurance Documentation ■ Account balances and transaction history ■
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Velloci Inc. chooses to share; and whether you can limit this sharing.

Who is providing this notice?

What we do

How does Velloci protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include various computer safeguards and secured files and buildings.

How does Velloci collect my personal information?

We collect your personal information, for example, when

- You activate your **Velloci** account
- You use linked banking/credit accounts
- You make changes to your account
- We make withdrawals and payments on your behalf

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes—information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law

Definitions

Affiliates

Companies related by contractual agreement to provide primary services for **Velloci, Inc.** They can be financial and nonfinancial companies.

- Velloci, Inc affiliates consist of financial providers such as banks and other financial or technology companies that work to service your financial needs

Nonaffiliates

Nonaffiliates we share with can include financial and nonfinancial companies.

- We do not sell your information to outside marketers to allow them to independently solicit you for a product unless we first ask your permission to send your information.

Joint marketing

A formal agreement between nonaffiliated financial or nonfinancial companies that together market financial products or services to you.

- Our joint marketing partners include banks, student loan providers, lenders and servicers, financial technology companies, credit card companies and other financial services companies.
- Joint marketing with other companies allows us to bring information to you about financial products and services that are different from those that we provide.

Other important information

CALIFORNIA RESIDENTS (consumer account with a California address): Please see the separate notice you are receiving entitled "Important Privacy Choices for Consumers" for your right to opt out of sharing with affiliates and with non-affiliated financial institutions that are joint marketing partners.

VERMONT RESIDENTS: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures. The information we may share pursuant to a joint agreement for marketing is limited to consumer name and contact information and our own transaction and experience information.

Important Privacy Choices for Consumers

THIS DOCUMENT APPLIES ONLY TO CALIFORNIA RESIDENTS

You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choices below. You have the following rights to restrict the sharing of personal and financial information with our affiliates (companies we own or control) and outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about some other products or services.

Your Choices

Restrict Information Sharing With Companies We Own or Control (Affiliates): Unless you say “No,” we may share personal and financial information about you with our affiliated companies.

NO, please do not share personal and financial information with your affiliated companies.

Restrict Information Sharing With Other Companies We Do Business With To Provide Financial Products And Services: Unless you say “No,” we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.

NO, please do not share personal and financial information with outside companies you contract with to provide financial products and services.

Time Sensitive Reply

You may make your privacy choice(s) at any time. Your choice(s) marked will remain unless you state otherwise. However, if we do not hear from you we may share some of your information with affiliated companies and other companies with whom we have contracts to provide products and services.

To Exercise your Choices

Do one of the following:
